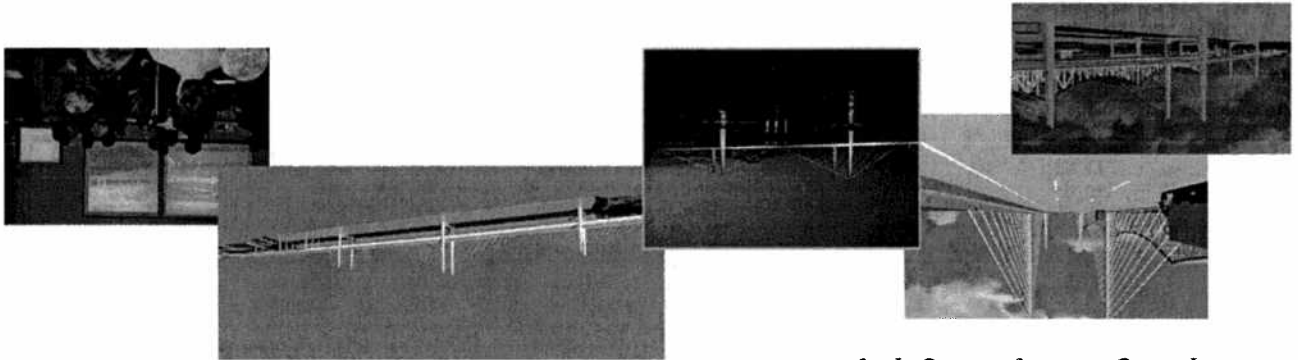
OCTOBER DINNER MEETING

“Unique Bridge Type Selection for the I-65 Downtown Louisville Bridge over the Ohio River”

Speakers: John Dietrick, P.E., S.E. – Michael Baker Jr. Inc.

Program: The Kentucky Transportation Cabinet and the Indiana Department of Transportation have initiated the design of a comprehensive new transportation plan that includes a new Ohio River crossing to carry I-65 between downtown Louisville, KY and Jeffersonville, IN. In consideration of the proposed new structure's prominence and proximity to this major urban center, a unique public involvement and bridge type selection process was employed. This talk will present the type selection process used for the new Downtown Louisville Bridge, including an overview of the first use of preference polling on a major bridge project.
