Program: The following award/project will be presented:
Outstanding New Short Span Bridge – This year’s recipient is the Crossover Taxiway Bridge at the Port Columbus International Airport. The single, 191-foot clear span was designed to carry a Group V aircraft weighing 900,000 lbs. The bridge superstructure consists of a post-tensioned, integral concrete frame with a slim mid-span depth of only 5-feet.


