Replacement of the I-35W Bridge

Speaker: Wade Bonzon, P.E. of FIGG, Project Director

Program: On August 1, 2007, the 40-year old I-35W bridge over the Mississippi River tragically collapsed. The efforts to rebuild this vital link in the Minneapolis transportation network began immediately. From team selection to design through the completion of construction, the Minnesota Department of Transportation fostered an extraordinary design-build process with one goal in mind: construct a new, state-of-the-art structure as quickly and safely as possible. The result is an architecturally stunning, highly durable, and redundant bridge structure in which the people of Minneapolis take great pride. This presentation will highlight the unique aspects and challenges of the design and construction process for the new I-35W bridge.
