Speaker: Jay Hyland, P.E. (TranSystems - Kansas City)

Program: Kansas City, the nation's second-largest rail hub, experienced immense congestion when its rail junctions were underperforming. From only utilizing one track with a 10 mph speed limit to now expediting time-sensitive trains on an unimpeded route, Kansas City has revitalized its once snarled route. Join us to learn more on how a well-designed junction can eliminate the choke point, triple train speeds, and shorten schedules. Project included rehabilitation of a 100 year old railroad bridge (2 miles long), new flyover railroad bridge (2,500 ft long) (triple track crossing) and track realignment.












