Temporary and Permanent Bridges: ACROW Panel Trusses



Speakers: Jeff Simkins, Acrow Bridge Corporation of America

Program: Mr. Simkins will discuss the best fits for panel truss bridges, and the design and maintenance of these bridges and roads both here and abroad. The presentation goes into the emergency bridge business; the recovery effort from hurricanes Katrina and Ivan and the World Trade Center. It explains how these temporary bridges help in phased construction and how they help the DOT's to recover user costs, reduce overall dollars spent and minimize the construction time window. Finally Mr. Simkins will discuss permanent uses of Acrow's bridges and launching methodologies.
